At the SGM on 18th August 2018 members adopted new subscription rules. The resulting subscription definitions and rates are shown overleaf.

I am writing to you now to show you the categories and rates that will be applied to your household for 2019 based on the information that is available to us and attaching a form for you to complete and return. Please return this form by 16th November and update, correct or confirm the information shown below. If this results in any changes to your subscription categories and rates, these will be reflected in the 2019 subscription letter that we will send, as usual, in very early December. If you respond after 16th November then any reduction applicable will not be applied in 2019 but in 2020.

We are not asking for money or showing your direct debit schedule now.

Please tell us your date of birth if the date(s) shown above are incorrect. The Club system has not held DoB of adult Members who have been Members for a long time. 01/01/1900 is the default if not known to the Club.

In particular senior Members should note that because we do not generally have their dates of birth we can only assume an inflationary increase on your 2018 subscription. You may be in a position to opt for the rates applying to OVER80s or to OVER70s but in the latter case the 2019 subscription shown above may already be less if you opted for a FROZEN subscription some years ago. Please request any changes by 16th November.

*Under 18 year olds may not be members without a parent or guardian also being a member.

General Notes

1. JUNIOR, YOUTH and YOUNG ADULT age ranges have each been extended by one year. Therefore each individual will remain in the younger group for an extra year
2. OVERSEAS subscriptions are 25% of the applicable ADULT, YOUNG ADULT, YOUTH or JUNIOR category. Overseas members must reside abroad and are restricted to 4 visits per year to the Club.

Notes about young family groups

1. The New FAMILY category includes 2 JOINT adults and all JUNIORS who reside at the same address. With one JUNIOR in the qualifying household the total subscription will be the same as 2018 (except for the inflationary increase) but with more than one JUNIOR the subscription is now lower.
2. If the FAMILY category has been applied to your household you will note it is expressed here as £215 for each of the 2 JOINT adults and £0 for all JUNIORS.
3. The JUNIOR subscription, if not within a FAMILY category, is £86 for 2019 (being 40% of ADULT). This will apply where there are not two adults in the household or not everyone resides at the same address.
 - a. If we have incorrectly assumed you qualify for the FAMILY category please tell us.
 - b. If there is only one adult member in your household you may apply for a partner to join, thus qualifying for the FAMILY, by completing the attached form. This will either not cost more or will be a marginal increase depending on how many JUNIORS are in your household membership. Subject to all residing at the same address.
 - c. If there is truly only one adult in your household you may be disadvantaged by the new subscription structure. The Committee is aware that such families may find this change a strain financially and asks that anyone who feels disadvantaged by it discusses their situation confidentially with the Secretary who holds discretionary authority to assist.
4. Families with no JUNIORS are not affected by these changes except that YOUTH or YOUNG ADULT members will retain their age category for an extra year, giving further financial benefit.

Notes about senior members (FROZEN, OVER70 or OVER80)

1. Those who received FROZEN subscriptions prior to 31st December 1995 maintain their current rate.
2. Those who received FROZEN subscriptions after 31st December 1995 will now pay a subscription equal to the same percentage of the single adult subscription that they paid in 2018.
 - a. The percentage of the ADULT rate is defined by your FROZEN subscription in this letter and £215.
 - b. If you qualify for OVER80 please tell us your date of birth and opt for the 40% discount being a subscription of £129 in 2019.
 - c. If you qualify for OVER70 please tell us your date of birth and you may opt for the 20% discount being a subscription of £172 in 2019. However if your 2019 subscription shown in this letter is less than £172 you do not have to opt for any change.
3. Those who have ADULT or JOINT subscriptions shown in this letter but qualify for OVER70 or OVER 80 may opt for a discounted subscription. This arises because the qualification period has been reduced from 20 years to 10 years. Again, please tell us your date of birth if shown incorrectly here.
